1. Alumni Association Rules and Regulations

Article 1: Name and Purpose

- 1.1 Name: The official name of this association shall be the "Institute of Language Teaching Alumni Association."
- 1.2 Purpose: The purpose of the Alumni Association is to foster a lifelong connection among the alumni, provide a platform for networking, and support the ongoing development and success of the Institute of Language Teaching.

Article 2: Membership

- 2.1 Eligibility: All graduates and former students of the Institute of Language Teaching are eligible for membership in the Alumni Association.
- 2.2 Membership Dues: Membership in the Alumni Association is free; however, the association reserves the right to introduce voluntary contributions or event-specific fees.
- 2.3 Rights and Privileges: Members have the right to participate in alumni events, receive newsletters, and access exclusive alumni resources provided by the Institute.

Article 3: Alumni Events and Activities

- 3.1 Organization: The Alumni Association may organize events, reunions, and networking activities to facilitate connections among alumni.
- 3.2 Collaboration: Alumni events should be coordinated with the Institute's administration to ensure alignment with the educational institution's values and objectives.
- 3.3 Event Participation: All alumni are encouraged to actively participate in association events, contributing to the vibrant community spirit.



Article 4: Communication and Information Sharing

- 4.1 Social Media: The Association may utilize social media platforms for effective communication and engagement. Members are encouraged to join official alumni groups for networking purposes.

Article 5: Alumni Support and Mentorship

- 5.1 Mentorship Program: The Alumni Association may establish a mentorship program to connect experienced alumni with current students for guidance and support.
- 5.2 Career Development: Alumni are encouraged to contribute to career development programs, share job opportunities, and provide internship opportunities for current students.

Article 6: Governance and Committees

- 6.1 The Alumni Association shall have a Board of Directors responsible for overseeing its activities and ensuring the association's mission is fulfilled.
- 6.2 Committees: The Board may establish committees to address specific objectives, such as events planning, communications, and fundraising.

Article 7: Amendments

- 7.1 Amendment Process: These rules and regulations may be amended by alumnus in their yearly meeting.

Article 8: Dissolution

- 8.1 Dissolution Procedure: In the event of the Alumni Association's dissolution, any remaining funds or assets shall be transferred to the Institute of Language Teaching for educational or charitable purposes.

Article 9: Adoption of Rules

- 9.1 Effective Date: These rules and regulations shall become effective upon approval by a majority vote of the Alumni Association's.

The meeting ended with a vote of thanks to the Principal and staff of ILT.


